### **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we identified areas where the District could make improvements. These recommendations are included with our report as a finding.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Klickitat County from January 1, 2020 through December 31, 2020.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, leave balances and accruals, leave cash outs, bonus and incentive payments
- Procurement public works and purchases
- Accounts payable general disbursements
- Compliance with state grants

# 2020-001 The District lacked adequate controls in place for ensuring compliance with state procurement laws.

#### Background

District management is responsible for designing, implementing and maintaining internal controls for ensuring compliance with state laws. Missing or inadequate internal controls can hinder the District's ability to comply with state laws. Procurement laws are intended to promote openness in government and prevent fraud, collusion and favoritism when awarding public contracts. In 2020, the District awarded 10 public works contracts totaling \$1,568,470.

State law requires the District to perform responsible bidder checks prior to awarding a contract for a public works project. These checks are designed to ensure contractors are properly licensed and registered with the state, have liability insurance, pay workers' compensation to the state, pay prevailing wages, and are not prohibited from working on state contracts.

# Description of Condition

The Legislature added a new responsible bidder requirement to state law effective July 2017, which requires governments to obtain a signed statement from the bidder certifying its compliance with established criteria to be considered a responsible bidder. The District did not ensure it updated its policies and procedures to include the additional requirement when conducting responsible bidder checks for contracts related to the District's construction projects.

# Cause of Condition

District officials were not aware of the changes to state responsible bidder requirements regarding obtaining sworn statements from contractors certifying that they have not violated labor laws in the last three years.

# Effect of Condition

Since the District did not obtain signed certifications, it cannot ensure it awarded the 10 contracts entered into during the audit period to responsible bidders.

#### Recommendation

We recommend the District comply with state laws regarding public works projects and competitive bidding by ensuring all contractors meet responsible bidder requirements before awarding a contract.

#### District's Response

In response to your recommendation, the District will modify procedures for public work contracts to obtain a sworn statement from contractors certifying that they have not violated labor laws in the last three years.

The District is diligent in performing numerous responsible bidder checks prior to awarding contracts for public works projects and going forward will adhere to all criteria identified within RCW 39.04.350 and the "Evaluation checklist for public contracts" published by the Office of the Washington State Auditor in September 2020.

The District required the 10 contractors awarded public works contracts to qualify for our works roster, which requires verification through Labor and Industries by staff and then approval by our commissioners. After the project is completed and prior to retainage release, contractors were again assessed for compliance with prevailing wage standards through Labor and Industries.

The District asserts these efforts provide reasonable assurance that contractors awarded public works contracts between 2017 and 2020 are; properly licensed and registered with the state, had liability insurance, paid workers' compensation to the state, paid prevailing wages, and were not prohibited from working on state contracts.

#### Auditor's Remarks

We thank the District for its cooperation throughout the audit and the steps it is taking to address these concerns. We will review the status of the District's corrective action during our next audit.

### INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Klickitat County (the District) consists of the electric system, nine water systems and five wastewater systems. The District also operates an additional water and wastewater system that are owned by other public entities. The District's service area covers approximately 1,680 square miles in Klickitat County. The District also serves small areas in the surrounding counties of Yakima, Skamania, and Benton. As of December 31, 2020, the District had 13,545 electric, 1,216 water and 1,270 wastewater customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's operations as well as its approximately 85 employees. For 2020, the District had annual operating revenue of approximately \$62.3 million, mostly from the operation of the electric system.
