Klickitat PUD employees are still at work during the current health crisis. Ensuring customers have access to electric, water and wastewater services is a critical function not just now, but going forward. Keeping these services available requires KPUD staff to remain healthy and able to work.

As new recommendations and requirements are released regarding COVID-19, Klickitat PUD continues to evaluate the best ways to keep employees safe and healthy. With that in mind, KPUD has developed work plans with employees for many positions that include telecommuting or modified work. This helps employees do essential work while reducing the potential for infection.

Work by Klickitat PUD employees would not be possible without the efforts of many other entities and their employees who continue to serve their essential functions. KPUD is fortunate to work in partnership with others during this crisis. As a result of the efforts of Klickitat County Emergency Management and the staff of Hood River Distillers, Klickitat PUD has been able to obtain a supply of hand sanitizing product. KPUD crews and staff greatly appreciate these efforts.

Washington State Department of Labor and Industries has restricted its inspection operations due to COVID-19. L&I will continue inspections of essential facilities. Klickitat PUD will provide installation services for those inspections. Once L&I resumes operations, Klickitat PUD will again process new service installation work for customers.

System repairs, maintenance of KPUD's infrastructure and the critical functions provided by internal staff will continue to ensure service remains available. In addition, both Klickitat Valley Health and Skyline Health hospitals offer a nurse helpline and COVID-19 testing within Department of Health guidelines. Local businesses are ready to assist where needed. Give them a call to see what options are available without having to go out in public.

Most recreational sites have been closed to the public. While it is safe and recommended to get fresh air, it is best to stay close to home and maintain a minimum of 6 feet from others to stay safe.
