GENERAL MANAGER'S REPORT TO THE BOARD

For the July 11, 2023 Meeting

AGENDA ITEMS:

- **A.** Moss Adams 2022 Financial Audit Presentation Keith Simovic will conduct a presentation of the 2022 audit results via teleconference.
- **B.** Power Transformers 2023: Reject All Bids and Call for New Bid Russ Patton will be present to request that we reject all bids and rebid these transformers. Only one bid was received, it exceeded the engineering estimate threshold and could not meet delivery date requested. The bid documents have been revised in an effort to obtain competitive bids.
- C. Public Hearing Electrical Industrial Rate Schedule 3A8 We have a public hearing at 3:00 p.m. On May 1st, 2019 the Industrial Rate threshold was increased to 2,000 average kW. The purpose of today's rate hearing is to decrease this threshold to 1,000 average kW to align with the upper threshold of the Large General Service Rate. Peak threshold of 2,500 kW remains intact.
- **D.** Electrical Industrial Rate Schedule 3A8 Adoption After holding the public hearing and consideration of any public comment has been evaluated, staff is recommending approval of the updates to Rate Schedule 3A8 as presented.
- **E.** Policy 21 Electric Customer Service The modification proposed within Policy 21, Section III Service Requirements changes the kW average load from 2,000 kW to 1,000 kW. This change provides between general service loads and large service load consistency within the policy.
- **F.** Policy 7 Credit Sales: Collections/Charges and Adjustments Modifications to Policy 7 are proposed to align with process changes in response to extreme heat moratorium and legislation (Section VII, F).
- **G.** Carbon Free Power Source, Small Modular Nuclear Reactor Investigation Mike DeMott and Kevin Ricks will provide an update at the meeting.
- **H.** Fire Mitigation Update Mark Garner and Mike Nixon will review the procedures that have been implemented for the fire season.

NON-AGENDA ITEMS:

1. <u>Rodger Nichols Newspaper Series "KPUD Straight Talk"</u> - The first article of the series was published in the Goldendale Sentinel on July 5. The second article is scheduled to be run July 12th. They will also be running on the Columbia Gorge News on a one-week delay and the online Columbia Community Connection as they receive them from us.

Attached are the first two articles, although the second is still a draft at this time.
