AGENDA ITEMS:

- A. <u>Professional Services Prequalification</u> Brandon Johnson will provide an update to the Professional Services roster for your review and approval.
- B. <u>Prequalification of Contractors</u> Purchasing has received additional responses to their request for qualifications. Cynthia Bruce will provide a list of qualified contractors and request that they be added to the works rosters.
- C. <u>Resolution 1848 Rescinding Credit Card Authority for Sohn Kartes</u> Cynthia Bruce will present the resolution to remove Sohn's credit card authorization since he has transitioned back to the maintenance department.
