

Residential Smart Thermostat Rebate

Qualified Products Only

Rebate for qualifying units \$100.00 (One smart thermostat per qualifying heating system with a limit of two per household)

Participation Requirements:

This rebate is available for existing and new construction single-family, and manufactured homes within the Klickitat PUD service territory.

Homes must have an electric forced-air furnace or air source heat pumps as their primary heating system. Smart thermostats are not recommended for Variable Speed heat pumps. Ground Source heat pumps do not qualify for the rebate.

Qualifying smart thermostats must:

- Be listed on KPUD's Smart Thermostat Qualified Products List; and
- Have occupancy detection set to "on"; and
- Be set to the geographic location where the thermostat is located.

In addition to the requirements above, thermostats controlling air source heat pumps must be programmed to recognize the existing heat pump system.

Thermostats that control cooling-only systems or dual fuel heating systems (gas furnace and electric heat pump) **are not** eligible for an incentive.

Privacy Notice:

Your interest in our conservation program is appreciated. We hope that you will decide to participate in these energy savings activities. If you do, it is necessary for you to provide some information to us, which will enable us to run this program successfully.

The information to be collected includes the names and addresses of customers participating in the program technical data about energy use and efficiency. We need this information to determine whether you are eligible for the program. Beyond this, the information collected will be used to evaluate and audit the conservation program.

Upon BPA's request, we will provide them with this information. BPA may also wish to make certain site visits to evaluate the installations and the performance of the program.

The data provided will then be used to assist us in developing new programs and in assessing energy savings obtained by existing programs in the region. This information will be retained for three years. It may be released to the public, but only in anonymous statistical form.

 - 7-day programmable or learning-based scheduling.
 - Wi-Fi enabled, with remote access.
 - Built-in occupancy sensor.
 - Heat pump auxiliary heat control and optimization.
